INDEMNITY BOND

(As per Regulation 14 of OERC Supply Code 2019)

THIS INDEMNITY BOND is made on this the day of 20.... at by aged about S/o permanent resident of village P.O., P.S., Dist. at present residing at P.O: - P.S. Dist. (hereinafter called the INTENDING CONSUMER).

WHEREAS, the intending consumer has applied for supply of power to the premises described fully in the schedule of this Bond of which, he is not the owner and at present, it is occupied by the INTENDING CONSUMER for the last Year(s) Month(s).

AND WHEREAS, the INTENDING CONSUMER undertakes to abide by the terms and conditions as may be prescribed by the Distribution Company/DISCOM, TP Southern Odisha Distribution Limited (herein after called as “**TPSODL**”) from time to time and in terms of the OERC Supply Code 2019 including any amendment that may be made from time to time, Electricity Act,2003 and other Acts and Regulations/Rules, which are in force and may come in future regulating the supply of electricity.

AND WHEREAS, there is/was no electric connection exists (now/previously) in the name of the INTENDING CONSUMER or anyone else over the land mentioned in the schedule of this Bond and no electric dues is pending against either in the name of the INTENDING CONSUMER or at the premises where the INTENDING CONSUMER seeks electricity connection at any point of time in any manner. The INTENDING CONSUMER hereby undertakes the following to get power supply from TPSODL, as below:

1) In case Government/Municipal Authority or any other authority demolishes the house / law enforcing agency / regarding sealing / vacation of the premises / in case where any suit is filed against TPSODL / direction by any statutory authority to which, the power supply has been given, TPSODL is at liberty to disconnect the electric connection and its meter and service line are to be removed from the premises/house situated over the scheduled land and the INTENDING CONSUMER undertakes not to raise any dispute on this issue.

In case of requirement and/ or direction to TPSODL to disconnect the power supply to the schedule land, TPSODL can disconnect the power supply and dismantle meter, immediately without notice to which, the INTENDING CONSUMER will not raise any objection. The INTENDING CONSUMER shall be held responsible for payment of all the electricity dues as per Regulation to the TPSODL without any objection.

2) That, the INTENDING CONSUMER undertakes, he/she shall be held responsible for any type of dispute arises at the time of installation of service connection (in future also) from the nearest LT line pole (including the right of way) to the scheduled land of the INTENDING CONSUMER.

3) That, in pursuance to Regulation-14 of the OERC Supply Code, 2019, the INTENDING CONSUMER binds himself/herself, his/her legal heirs, successors, jointly and severally to indemnify and keep harmless to the TPSODL for any sum, against any expenses incurred or likely to incur for any loss and / or damage of any kind whatsoever including interest that may be caused to or suffered by and / or likely to cause or suffered by TPSODL (towards any dispute) relating to supply of power to the INTENDING CONSUMER at the premises described in the schedule of this Bond. The INTENDING CONSUMER shall pay litigation charges / charges for any damages to TPSODL irrespective of the fact whether any costs are granted by the Judicial/quasi-judicial authorities/courts or not.

4) The INTENDING CONSUMER as per Regulation 8 of the OERC Supply Code 2019, while availing power supply to the schedule land by virtue of this Indemnity Bond, undertakes not to use this Bond or the Electricity Bill issued by TPSODL on the basis of this Indemnity Bond as a piece of documentary evidence for the purpose of lawful occupation of the premises mentioned in the schedule in any municipal record, revenue record or any Court of Law or before any other Authority as proof of ownership or legal title to the schedule land.

5) That the INTENDING CONSUMER undertakes not to extend any connection to anybody from his/her power supply or change purpose of use or enhance the contract demand in violation of the Electricity Act, 2003 and OERC Supply Code, 2019. If the intending consumer is found extending the connection to anyone, TPSODL shall have the right to disconnect the supply immediately without serving any notice.

6) TPSODL shall not be held responsible for any act of safety hazards and electrical accident over the said premises and shall not pay any compensation for the same. The INTENDING CONSUMER undertakes for acceptance of all the responsibility on account of the above.

7) The intending consumer shall provide an adequate and safe place for the installation of the meter and shall keep the meter in a safe and intact condition. TPSODL shall not be responsible for any kind of damage to the meter.
