NOTIFICATION

No. 8309 /En., Bhubaneswar, dated the 0//10/2015

In pursuance of Sub-section-I of Section-3 of the Orissa Electricity (Duty) Act-1961 and supersession of the notification No. 1 RE(ED) 26/2005 dated the 01.06.2006 issued by Govt. of Odisha in the Department of Energy as amended from time to time, the State Govt. do hereby specify the rates as mentioned in column No.-(3) of the table below at which Electricity Duty shall be levied & paid to the State Govt. on the energy consumed by the category of consumer or for the category of consumption as specified in column No. (2) thereof with effect from 1st of October, 2015.

Schedule of Rates

SI. No.	Category of Consumer or Consumption	Rate of Electricity Duty/ per Unit / Percentage of Electricity Charges
1	Irrigation Pumping and Agriculture for all supply voltage	2 % of the energy charge
2	L.T. non-industrial category	4 % of the energy charge
3	Small Scale Industry [L.T. Industrial Supply]	5 % of the energy charge
4	L.T. Industrial Category (Excluding Small Scale industry)	8 % of the energy charge
5	H.T. Category	8 % of the energy charge
6	E.H.T Category	9 % of the energy charge
7	Any person not being a licensee or Board who generates energy for his own use or consumption	30 Paise per unit
8	A licensee or Board in its own Premises	30 Paise per unit
9	Public water works and sewerage pumping and Railway traction	Nil

The consumer who is receiving power through open access / by special agreement between the licensee and consumer approved by OERC will pay Electricity Duty in the similar manner as it would have been paid for the supply availing from the licensee.

(ii) Small Scale Industry (L.T. industrial supply):

All the consumers availing power supply for industrial purpose with contract demand below 22 KVA at voltage less than and including 650 Volt.

(iii) L.T. Non-Industrial Category:

All the consumers like domestic, general purpose, street lighting, public institution etc. availing power supply at voltage less than and including 650 volt for their own use except for industrial purpose and excluding category (i) above.

(iv) L.T. Industrial Category:

All the consumers availing power supply at voltage less than and including 650 volt for their own Industrial use excluding Small Scale industry.

(v) H.T. Category:

All the consumers availing power supply at high voltage above 650 volt up to and including 33000 volt for their own use and excluding category (i) above.

(vi) E.H.T. Category:

All the consumers availing power supply at extra high voltage above 33000 volts for their own use.

(vii) Open Access / Consumer Receiving power by Special Agreement Approved by OERC:

The consumer who is receiving power through open access / by special agreement between the licensee and consumer approved by OERC will pay Electricity Duty in the similar manner as it would have been paid for the supply availing from the licensee.

Explanation-1:

Where Electricity Duty calculated on the basis of the energy charge in respect of consumers or consumption mentioned in SI. No.1 to SI. No.6 exceeds 40 paisa per unit, it shall be limited to 40 paisa per unit.

Explanation-2:

(i) <u>Irrigation pumping and agriculture for all supply voltage:</u>

All the consumers availing power supply for pumping of water in lift irrigation, Flow irrigation and for lifting of water from wells, nollahs, streams, ponds, dug wells exclusively for agricultural purposes at all supply voltages.

(ii) L.T. Non-Industrial Category:

All the consumers like domestic, general purpose, street lighting, public institution etc. availing power supply at voltage less than and including 650 volt for their own use except for industrial purpose and excluding category (i) above.

(iii) Small Scale Industry (L.T. industrial (S) supply):

All the consumers availing power supply for industrial purpose with contract demand below 22 KVA at voltage less than and including 650 Volt.

(iv) L.T. Industrial Category:

All the consumers availing power supply at voltage less than and including 650 volt for their own Industrial use excluding Small Scale industry.

(v) H.T. Category:

All the consumers availing power supply at high voltage above 650 volt up to and including 33000 volt for their own use and excluding category (i) above.

(vi) E.H.T. Category:

All the consumers availing power supply at extra high voltage above 33000 volts for their own use.

(vii) Open Access / Consumer Receiving power by Special Agreement Approved by OERC:
